The website

Use of cookies

What are cookies?

Cookies are small files saved to the user's computer's hard drive that track, save and store information about the user's interactions and usage of the website. This allows the website, through its server to provide the users with a tailored experience within this website.

What do we use cookies for?

We may use cookies to remember personal settings you have chosen at our website. In no other context do we use cookies to collect information that identifies you personally. Most of the cookies we set are automatically deleted from your computer when you leave our website or shortly afterwards.

We use anonymous session cookies (short-term cookies that disappear when you close your browser) to help you navigate the website and make the most of the features. If you log into the website, application or a course as a registered user, your session cookie will also contain your user ID so that we can check which services you are allowed to access.

This website uses tracking software to monitor its visitors to better understand how they use it. This software is provided by Google Analytics which uses cookies to track visitor usage. The software will save a cookie to your computer's hard drive in order to track and monitor your engagement and usage of the website, but will not store, save or collect personal information.

Should users wish to deny the use and saving of cookies from this website onto their computer's hard drive, they should take necessary steps within their web browser's security settings to block all cookies from this website and its external serving vendors.

We will hold data on you for one or more of the following reasons:

You have chosen to become a Member via our website. All data is held securely at Node4 (www.node4.co.uk) which is UK based. The latest firewall protections are in place. Backups are done on a daily/weekly/monthly basis and a full backup and deletion schedule is in place.

You have opted in to receive a newsletter or other marketing communications. We usually use ConstantContact for our email communication. You can opt out of these at any time via the links at the bottom of the emails. Alternatively, please email anna.naylor@maiden-voyage.com.

You sign up to the Maiden Voyage Webinar Series. Orders will usually be processed via EventBrite. These webinars are delivered via the platform GoToWebinar. Your data will be deleted from both platforms within 30 days of the end of the live webinar date.

You agree to take part in a Survey via <u>SurveyMonkey</u>. In most instances this will be anonymous, however where personal data is required, it will be deleted within a time period relevant to the survey being analysed. Please ask for more details relating to specific surveys.

Whilst using our website, software applications or services, you may be required to provide personal information (name, address, email, account details, etc.). We will use this information to administer our website, applications, client databases and marketing material. We will ensure that all personal information supplied is held securely in accordance with the Data Protection Act 1998. Further, by providing telephone, fax and email details, you consent to Maiden-Voyage.com contacting you using that method. You have the right at any time to request a copy of the personal information we hold on you. Information collection and use

How do we collect information?

Maiden-Voyage.com Ltd collects information in two possible ways:

a. When you directly give it to us ("Directly Provided Data")

How long do we keep your data for?

We will hold onto the information you provide either while your account is in existence, or as needed to be able to provide the Services to you, or (in the case of any contact you may have with our Customer Care team) for as long as is necessary to provide support-related reporting and trend analysis only.

If legally required or if it is reasonably necessary to meet regulatory requirements, resolve disputes, prevent fraud and abuse, or enforce our Terms and Conditions, we may also retain some of your information for a limited period of time as required, even after you have closed your account or it is no longer needed to provide the Services to you.
